GENERAL OVERVIEW OF KHARONBRIDGE

KharonBridge is a digital platform dedicated to personal memory, designed to offer a private, secure, and controlled space for preserving, organizing, and transmitting meaningful memory elements.

The platform is structured around two distinct spaces, addressing different uses and temporalities:

The Grief Space

This space is intended for individuals facing the loss of a loved one. It allows users to create an intimate environment in which they can gather memories, write personal letters, and light symbolic candles.

The Grief space is designed as a strictly private framework, with no public exposure or social networking logic, allowing each person the freedom to express, preserve, or revisit their memories at their own pace.

The “Leave a Trace” Space

This space is intended for users who wish to transmit a memory during their lifetime. It allows for the structuring and preservation of messages, documents, letters, or time capsules intended to be consulted later by designated loved ones.

The Leave a Trace space is part of an approach focused on transmission, continuity, and preparation, independently of any notion of immediate grief.

Regardless of the space used, KharonBridge is built on shared principles:

privacy by default, full user control over content, and absolute neutrality on religious, ideological, and therapeutic levels.

The platform is positioned neither as a social network nor as a medical, psychological, or religious service. It does not interpret content and is not intended to replace professional support.

KharonBridge is a digital tool with a memorial purpose, offering a structured and lasting framework for the preservation and transmission of personal memories.

Accessible online, the platform adopts a progressive model combining limited free use with extended features available through subscription, without compromising the confidentiality or ownership of user content

THE NEED ADDRESSED

In this context, personal memory related to the loss of a loved one or to the transmission of one's own life experience remains insufficiently addressed. Existing solutions generally consist of public memorial spaces, social networks not designed for this purpose, or fragmented technical tools, without real continuity or long-term guarantees of confidentiality.

For individuals experiencing grief, this lack of an appropriate framework can make it difficult to preserve memories within an intimate, respectful, and stable space, away from public exposure or external judgment. Similarly, people wishing to organize and transmit a trace of their life during their lifetime have limited access to digital tools that allow them to structure this process in a voluntary, controlled, and lasting manner.

There is therefore a growing need for digital spaces dedicated to personal memory, capable of addressing sensitive and differentiated uses: supporting a grieving process within a private framework, or enabling the conscious and anticipated transmission of memories and messages.

This need is expressed through several fundamental expectations:

- confidentiality of content, with no public dissemination by default;
- data durability, beyond short-term uses or social media platforms;
- user control, both over access and content organization;
- neutrality of the system, which imposes no religious, therapeutic, or ideological orientation, while leaving users complete freedom to express their personal convictions or symbolic references within a private framework.

KharonBridge addresses this need by offering a structured digital framework, specifically designed to meet these expectations, where existing solutions remain unsuitable or insufficient.

KharonBridge provides a structured response to the need for preserving and transmitting personal memory by offering a digital platform specifically designed for sensitive uses, where existing tools remain general-purpose, fragmented, or unsuitable.

The solution is built on a clear architecture, structured around two distinct yet complementary spaces — Grief and Leave a Trace — each addressing specific intentions, temporalities, and use cases, while sharing a common foundation of technical and ethical principles.

A platform designed for private and controlled use

KharonBridge allows users to centralize their memorial content within a single, secure, and durable environment. Texts, personal letters, documents, time capsules, or symbolic elements can be organized coherently, with no public exposure by default and no social visibility logic.

Access to content is strictly controlled by the user, who freely defines the conditions for consultation, preservation, and, where applicable, transmission to designated individuals.

A differentiated response based on user intent

Within the Grief space, the platform provides a framework for personal expression, the preservation of memories, and the inclusion of symbolic gestures, following principles of respect and discretion.

Within the Leave a Trace space, KharonBridge enables the anticipation of message and memory transmission by structuring a voluntary approach to continuity and preparation.

These two spaces share the same requirements for confidentiality and control, while addressing distinct needs without conflating them.

Technology in service of meaning, not exposure

KharonBridge integrates advanced digital functionalities in a deliberately restrained manner. Technology is used as a support, not an end in itself, and is never intended to guide, interpret, or influence the content produced by users.

Any automated assistance offered by the platform operates within an informative or symbolic framework, without prescriptive or decision-making character, and without substituting for professional support.

A progressive and respectful model

The solution is accessible online through a progressive model combining limited free use with extended features available via subscription. This model allows for a simple introduction to the platform while ensuring, at all levels of use, the confidentiality, ownership, and user control of content.

Through this approach, KharonBridge positions itself as a digital solution dedicated to personal memory, designed to endure, adapt to individual use cases, and respect the uniqueness of each personal journey.

ETHICAL POSITIONING AND COMPLIANCE

From its inception, KharonBridge has been designed around a strict ethical framework, taking into account the sensitivity of uses related to personal memory, grief, and the transmission of intimate messages. The platform adopts a deliberately responsible posture, aimed at protecting users, their content, and their freedom of expression.

Neutrality and system responsibility

KharonBridge is built on a fundamental principle of tool neutrality. The platform imposes no religious, spiritual, ideological, or therapeutic orientation and provides no interpretation of the content created by users.

This neutrality does not limit personal expression: each user remains fully free to incorporate, within their private space, the symbols, beliefs, or references that are meaningful to them. Responsibility for meaning and content lies exclusively with the user.

KharonBridge does not position itself as a social network, nor as a medical, psychological, or religious service, and is not intended to replace professional support.

Confidentiality and user control

Confidentiality is a central pillar of the platform. Spaces created on KharonBridge are private by default and are not subject to any public dissemination. Access to content is strictly controlled by the user, who freely defines the individuals authorized to view or receive specific elements.

Users retain full control over their content at all times, including its organization, deletion, and transmission.

Data protection and regulatory compliance

KharonBridge applies a “privacy by design” data protection approach, in compliance with the requirements of the General Data Protection Regulation (GDPR). Data collection is limited to what is strictly necessary for the operation of the service, and purposes are clearly defined.

Personal data and emotionally sensitive content are neither used for advertising purposes nor transferred to third parties. Users benefit from rights of access, rectification, and deletion of their data, in accordance with applicable regulations.

Responsible use of technology

Technologies integrated into KharonBridge are implemented to serve the user experience without encouraging dependency, influence, or over-interpretation. Any automated assistance offered by the platform operates within an informative or symbolic framework, without prescriptive or decision-making intent, and without replacing professional support.

Through this positioning, KharonBridge affirms its commitment to providing a durable, respectful, and compliant digital solution, aligned with ethical and regulatory standards applicable to sensitive use cases.

KharonBridge is built on a progressive business model, designed to balance accessibility, service sustainability, and respect for the sensitive nature of personal memory use cases.

The platform adopts a freemium approach, allowing users to discover and use essential features without financial commitment, within a strictly private and secure environment. This approach ensures accessibility while respecting the intimate nature of the proposed uses.

Extended features are available through a subscription, offering in particular enhanced storage, organization, and transmission capabilities for memorial content. This subscription-based model ensures the technical continuity of the platform, data security, and the progressive evolution of services, without reliance on advertising or commercial exploitation of personal content.

In addition, certain specific features or services may be subject to separate billing when their use involves particular processing or individualized added value. These options remain strictly optional and do not affect access to content already created by the user.

KharonBridge's business model is designed to remain aligned with its ethical commitments:

no monetization of personal data, no targeted advertising, and no external commercial use of user content. The value created relies exclusively on the service provided to users and on the durability of the infrastructure made available to them.
